TSCA Title VI

TSCA Title VI is a U.S. regulation that sets formaldehyde emissions standards for composite wood products, such as hardwood plywood, medium-density fiberboard (MDF), and particleboard. Title VI requires composite wood products to be certified by third-party testing laboratories.
